Your name will then be added to the membership list and posted at the lake. Remember that by signing the waiver that you are agreeing to make sure that your family and your guests are following the guidelines that are posted at the lake : no dogs, no glass bottles, no roughhousing, use fire pit responsibly, take your trash with you for proper disposal. We ask that you generally be good caretakers of our beautiful lake.

SOC has hired Censor Security service again this year. The security guard is at the lake throughout the summer to insure compliance with the rules and encourage a safe and pleasant experience for everybody. Please take a moment to introduce yourself.

Our spring work day is scheduled for Saturday, May 13 at 12:30. Hope that you can join us. Thanks in advance for those who help to keep our swimming area in tip top shape.
