1	Guest: Laura Black	<p>Planning Commission working on Town Plan due early 2027. Encouraged us to read full Unified Subdivision and Zoning Regulations but there are specific sections that might interest us. No plans for amending bylaws. Welcome to provide input for distant future consideration. Pay attention to Class 4 Roads, Meadowlands, how “scenic” is defined.</p> <p>Class 4 Road Policy amendment draft has been reviewed by Selectboard and minor wording changes have been requested by Selectboard. SCC members asked Laura if language can be clear as to whether certain types of motorized vehicles will be addressed in the final language. Selectboard asked the Planning Commission to draft a different permit for when maintenance access is needed on Class 4 Roads.</p> <p>Reminder of Dam Removal meeting tomorrow. No details shared.</p>

8	Invasives	Pam would like communication with road crew so that she is not pulling invasives on roads on same days that road crew is doing work. Pam and Weezie will start line of communication with future new road commissioner. Give Pam your volunteer hours.

9	Bat Boxes	MRU woodshop class makes batboxes. Do we want to ask them to build any? We can purchase for supply cost. Questions back from SCC, Carrie will follow up: How many chambers? Are dividers removable? Is inside treated? How many boxes can be built? Does school want to partner on a fundraiser and us to take orders? Do we also want to suggest bluebird boxes?
10	Wildlife Crossings	Jens has updated his maps with SCC data. He will include lynx sightings, bear sightings and bear signs. He will make 3 maps for SCC: <ol style="list-style-type: none"> 1. simple 4 years of data 2. Our data overlaid with biofinder 3. Our data overlaid on planning commission wildlife corridor map <p>He will also send a large scale map that SCC can mount and will be portable to be used at meetings in town. Jens confirmed that our data IS reality and he is willing to come to meetings to add credibility from fish & wildlife department if needed. Jens does not want any more seasons of deer tracks recorded. OK to send springtime bear sightings to Linda. This coming winter will be the last year of the project. Too late now to add mile square to this project's data. Suggestion to partner with Mt. Holly in the future on this, encourage a future project. Confirmed 11/2 wildlife tracker kickoff celebration 1-3 pm.</p>
